Pages 3 and 4: **Proposed artists for Pinta Miami 2023:** Include complete name, short bio and or statement, (website and social media if needed). Maximum of two (2) pages.

Pages 5 to 7: **Art work images:** Include a minimum of 1 and a maximum of 5 artwork images per artist proposed in the PDF (they should not be attached in the email), with their corresponding technical information (Gallery name, Artist name, Title, year, technique, dimensions, editions -if applicable-). Maximum of two (2) pages.

**Payment terms**

After acceptance by the Selection Committee, exhibitors will be invoiced for the total of the cost, 100% of payment is due upon confirmation. There are strict rules about the withdrawal of applications. These rules affect the ability to obtain a refund, so please read below very carefully. The Exhibitor agrees that if the total amount has not been received by PINTA ART LLC by November 1st, 2023, PINTA ART LLC shall have the right to treat Exhibitor’s failure to pay as a material breach of the contract, retain any payments previously made to PINTA ART LLC, and recover from Exhibitor the total booth rental amount, plus any collection costs incurred by PINTA ART LLC (including attorneys’ fees) in enforcing its rights to collect such payment and costs. The exhibitor agrees that in the event that it has failed to make the required payments, its non-payment will constitute a material breach of its agreement with PINTA ART LLC, and PINTA ART LLC may reallocate the space formerly devoted to that exhibitor as PINTA ART LLC sees fit. Failure to make payments by deadlines will result in automatic charges to the exhibitor’s credit card, and by signing below they irrevocably authorize and accept such automatic charges. Credit card fees (3%), wire, and transfer fee if any will be paid by the gallery.
